2. Pole Size: 4 inch of 18 gauge thickness and pole Height (length): 20 Ft. – 2 Poles (Inclusive of Hoarding/Boards height (length).Drawing is enclosed for reference).
3. 1" square Metal frame for the above mentioned sizes. As per design.
4. G I sheet affixed on the frames for the above mentioned sizes.

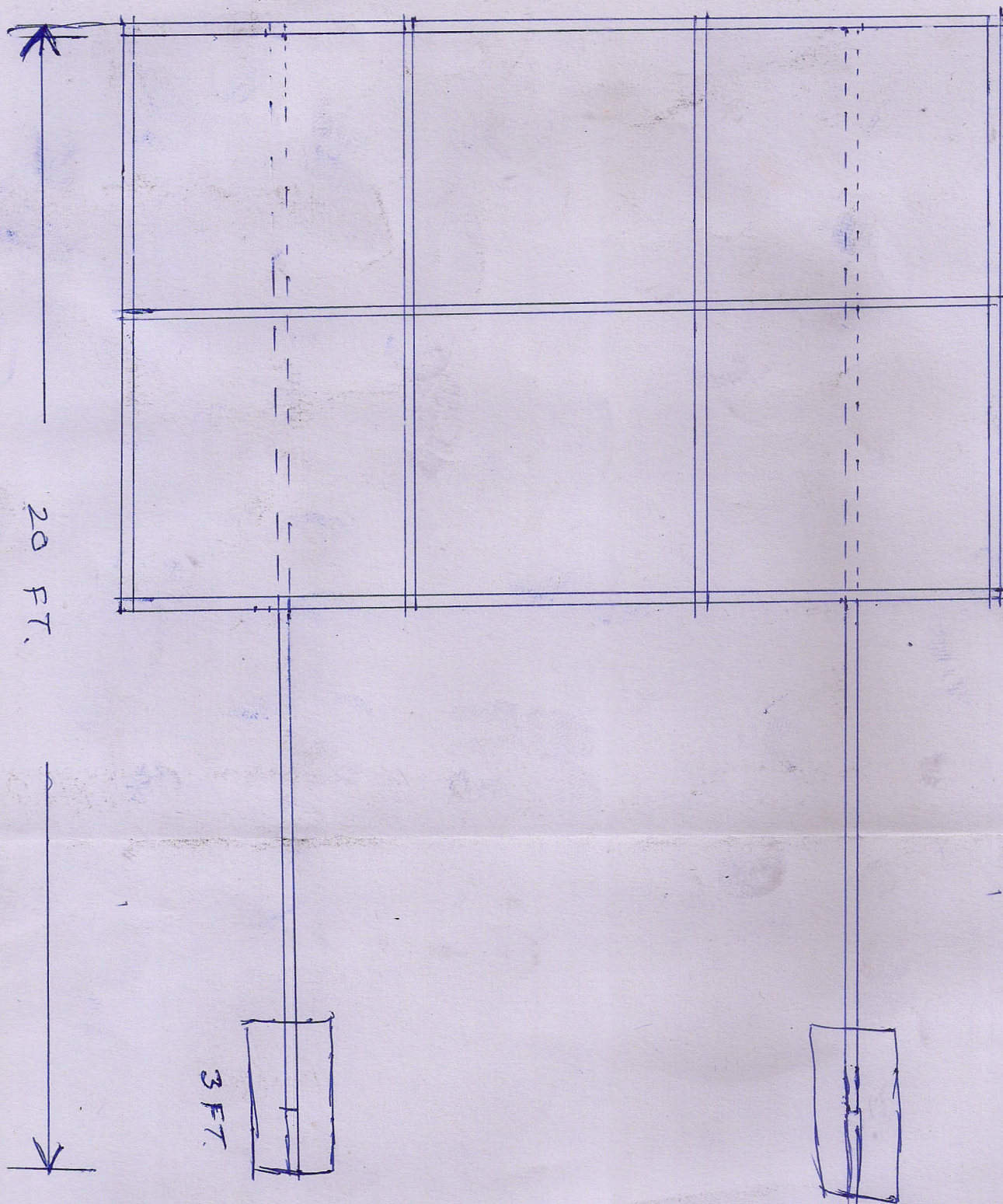
The Fabrication and erection of Two (2) Hoardings/Boards including the Civil works like digging the ground, concreting the pit and completing the civil works with safety measures is the responsibility of successful bidder. The successful bidder shall also maintain the Hoardings/ Boards in proper condition so that the advertisements are clearly visible to the public throughout the contract period. In the event of any damage/collapse of the Hoardings/Boards during the contract period, the successful bidder has to take immediate repair/rectification work at his own risk and expenditure.

**The SMOI will hire the 2Hoardings/Boards for a period of One (1) Year on Rental Basis only from the date of completion of erection and mounting of the flex** and may extend for one more year subject to the approval by the Authorities concerned.

**GENERAL TERMS AND CONDITIONS**

1. **RATES & APPLICABLE TAXES:** The parties should clearly quote the rental amount for 2 Hoardings/Boards on monthly basis and applicable rate of taxes in their quotation. In case no taxes are mentioned it will be presumed that rate is inclusive of all taxes.
2. **VALIDITY:** The rates quoted should be valid for a minimum period of 120 days from the date of opening the quotation.
3. **ESCALATION CHARGES:** No escalation charges will be entertained once the quotation is accepted and contract awarded.
4. The permission from the Town Municipal Office, Doddaballapur is obtained for 2 hoardings and further approvals from other authorities like PWD if any, shall be obtained from the bidder.
5. **EMD:** The quotation should be accompanied with an EMD amount of 2%. The EMD amount may be calculated for the total rent claimed for one year and sends directly to Central Bank of India, Rajajinagar, Bangalore through RTGS/NEFT etc., CA No.3006204383, IFSC Code No.CBIN0281200 or DD in favour of "Silk Mark Organization of India" Payable at Bangalore. **Quotations received without EMD will be summarily rejected.**
6. **LAST DATE:** The last date and time for the submission of the sealed competitive quotations is **13<sup>th</sup> August, 2018 upto 1.00 PM**. 7. **OPENING THE QUOTATIONS:** The quotations, so received well within the stipulated time, will be opened on **13<sup>th</sup> August, 2018 at 4.00 PM** at the office of the Silk Mark Organization of India, #14, Vatal Nagaraj Road, Okalipuram, Bangalore-560 021. The bidders or their authorized representatives may remain present at the time of opening of the tenders, if they so desire.
8. **INCREASE OR DECREASE OF THE QUANTITY:** The Deputy Director (Insp.), SMOI reserves the right to increase or decrease the quantity of the number of Hoardings/Boards.
