## Terms and Conditions

1. Mobile Display Vehicle should be on road from morning **10.00 AM to 8.00 PM**
2. Mobile Display Vehicle should work for 30 Days from 12.09.17 to 11.10.17 or the campaign may be restricted to 15 days (27.09.17 to 11.10.17) as decided by the authority
3. Total display area to be covered by flex is (display) Board of 8 ft x 6 ft x2 with lit, van top(3ftx2ft) above driver seat, both the side portions(10ftx1.5ftx2) and back side of the driver seat (8ftx2ft x2) **covering a total area of approx.166 - 170 sqft.** Any clarification, please contact SMOI, Chennai Chapter.
4. The Mobile Display Vehicle should cover a **distance of 50 Kms per Day**
5. The rate quoted should be inclusive of flex printing, framing and fixing charges, removing charges. Only art work for the above display will be provided by SMOI.
6. **All the necessary permissions from Police, Municipality etc. have to be obtained by the party and fulfilling the legal formalities is rest with party and SMOI is not responsible for any lack on the part of the party.**
7. **The Mobile Display Vehicle should adhere to the Local Traffic Rules/arrangements and there should not be any violation**
